**Due to road works on N7 slight change in directions from Dublin.  
Diversion off N7 into Nenagh will take you into Nenagh town on Thurles road.  
Straight into town and at traffic lights go right. Keep straight on this  
road and this will bring you out on N52.**

~~Take first exit off N7 into Nenagh. At T junction (mini roundabout) go right on N52 for Birr/Borrisokane.  
Keep on N52 for one mile. Pass Gleeson Farm Machinery on your left. Take next left on R493 for  
Ballinderry/Puckane. (Opposite AIBP meats) One mile take first left.~~

**From Limerick:** Take first exit off N7 into Nenagh. At roundabout head onto N52 for Birr/Borrisokane. Keep on N52. Pass 'Gleeson Farm Machinery' on your left. Take next left on R493 for Ballinderry/Puckane. (Opposite AIBP meats) One mile take first left.

**From Birr/Athlone:** Pass through Ardcroney village. 5 miles turn right on R493 for Ballinderry/Puckane. (Opposite AIBP meats) One mile take first left.
